


What is Sumbangan Tunai Rahmah (STR)?

• STR is one of the initiatives under the **Payung Rahmah** concept which aims to help the underprivileged in **facing the cost of living challenge.**









Eligibility by category:

- 1) Household
- a) Married; or
- b) Single Mother or Father / Widow / Widower who has children who meet the conditions; and
- c) Household income is RM5,000 and below.





Eligibility by category:

- 2) Senior Citizen without Spouse
- a) Single or Single Mother or Father / Widow / Widower who does not have children who meet the requirements; and
- b) The age limit is 60 years and above; and
- c) Household income is RM5,000 and below.





Eligibility by category:

- 3) Single
- a) Single or Single Mother or Father / Widow / Widower who does not have children who meet the requirements; and
- b) The age limit is within 21-59 years; and
- c) Single income is RM2,500 and below.





• Note: Single individuals aged 21 years and above who are still studying full-time at Public / Private Higher Education Institutions are only allowed to be included in the information of children / dependents of the household application and are not allowed to apply as single individuals





When will STR applications open?

- i. Online from 1 March 2023 31 March 2023
- ii. Manual from 8 March 2023 31 March 2023

*subjected to changes from time to time







Application method

Online application: You can visit the following website at https://bantuantunnai.hasil.gov.my. In addition, applications can also be made through the Sumbangan Tunai Rahmah App by downloading it from the Play Store or App Store.

Manual application: Go to IRB Office, IRB Satellite Office (PS), IRB Revenue Service Center (PKH) and IRB Urban Transformation Center (UTC) by filling in and submitting the STR Application Form, (BK-01).



How to apply?

MySTR information is based on MyBKM 2022 information.

Log in to your mySTR account at Bantuan Tunai official website. If your log in is successful, you only need to update your latest information. But if your log in is unsuccessful, you need to make a new application via either online or manually using form.






Step 1: Log in to https://bantuantunnai.hasil.gov.my and click on 'Permohonan Baharu'







Step 2: Fill in the applicant's information. Fields marked with (*) are mandatory.






Step 3: After all information has been filled, confirm by entering the Captcha Code displayed on the screen and press the "SAHKAN CAPTCHA" button.





Final Step: Submit the application form by clicking 'Hantar'





Step 1: Go to https://bantuantunnai.hasil.gov.my/. Then, click the 'Log Masuk' button to update the application.





Step 2: Enter the registered 'User ID' and 'Password'.

Step 3: Click on the 'Kemas kini' button after logging in. Then fill in the applicant information again. Fields marked with (*) are mandatory.





Step 4: After all information has been filled, confirm by entering the Captcha Code displayed on the screen and press the "SAHKAN CAPTCHA" button.

STR payment will be implemented as follows:

No.	Payment Phase	Payment Date	
1	Phase 1	Starting January 17, 2023 by stages	
2	Phase 2	April*

How is STR payment method implemented?

i. Credited to Bank Account

Payment will be credited to the recipient's / spouse's bank account in stages.

ii. Cash payment at Bank Simpanan Nasional (BSN) if:

- a) No bank account information
- b) The crediting status shows failure





What is the additional RM600 STR and who is eligible to receive?

The additional rate of STR amounting to RM600 is dedicated to household recipients that have been identified as being in the extreme poor category.

Eligibility for this additional rate is limited to:

- i. household recipients listed as Extreme Poor in e-Kasih data records; and
- ii. must have household income not exceeding PGK Miskin Tegar RM1,169 based on revenue agency cross-checks





How is the STR additional rate contributed?

• This donation will be channeled in the form of food baskets and also in the form of vouchers for basic food items worth RM100 for a period of 6 months.
